

MEMORANDUM FOR THE CHIEF OF STAFF

Under the authority of Section 1552, Title 10, United States Code, and Air Force Instruction 36-2603, and having assured compliance with the provisions of the above regulation, the decision of the Air Force Board for Correction of Military Records is announced, and it is directed that:

The pertinent military records of the Department of the Air Force relating to [REDACTED] be corrected to show that on 25 July 1997 he enlisted in the Air Force Reserve in the grade of airman first class (E-3) rather than airman (E-2); and, at the time of his enlistment on 25 July 1997, he was eligible for an enlistment bonus in accordance with AFRESI 36-2603.
