**REVIEW OF NAVAL RECORD**

1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show the period of time he graduated from the Naval Academy and when he started classes at the Uniformed Services Health Sciences Education Training Command, Bethesda, MD counts toward his pay entry base date (PEBD).

2. The Board, consisting of Messrs. Dunn, Flood, and Swarens, reviewed Petitioner's allegations of error and injustice on 13 October 1999 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

**CONCLUSION**

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:

a. When Petitioner graduated from the Naval Academy on 17 May 1992 he was awarded a designator of 1100 and worked as an 1100 until 16 August 1992. He reverted to a designated of 1975 on 17 August 1992, on entry into the Health Sciences Education Training Command, Bethesda, MD. The period of time, 17 May 1992 to 16 August 1992, inclusive should count toward Petitioner's PEBD.

b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.


