MEMORANDUM FOR THE CHIEF OF STAFF

Under the authority of Section 1552, Title 10, United States Code, Air Force Instruction 36-2603, and having assured compliance with the provisions of the above regulation, the decision of the Air Force Board for Correction of Military Records is announced, and it is directed that:

The pertinent military records of the Department of the Air Force relating to [REDACTED], be corrected to show that he was credited with an additional 20 nonpaid inactive duty points during the retirement/retention year 22 August 1949 through 21 August 1950, resulting in 50 total points; and, that the period 22 August 1949 through 21 August 1950 is a year of satisfactory Federal service for retirement.





SUBJECT: Application for Correction of Military Record,  


1. The requested correction cannot be accomplished administratively at this headquarters.
2. The applicant is requesting 20 points and a satisfactory year of service for the period 22 August 1949 to 21 August 1950, and a Reserve retirement.
3. The following is an analysis of the circumstances surrounding the case:

a. The applicant was a member of the Air Corps Enlisted Reserve from 11 February 1944 to 13 July 1949. re-enlisted with the Air Force Reserve on 22 August 1949 where served until his discharge on 10 November 1966.

b. The applicant states attended and participated in the required Reserve duty weekend training for the timeframe in question. did not receive the Inactive Duty Training (IDT) points.

c. After 1 July 1949 service is determined by Retention/Retirement (R/R) year. Service is creditable for retirement if 50 points have been accrued for a full R/R year. Since the time in question was during the timeframe when points were first being recorded, it is possible not all points were documented.

d. During the period 22 August 1949 to 21 August 1950, documentation in the applicant's record indicates did participate. was credited with 15 Active Duty (AD) Training days from 27 May 1950 to 10 June 1950. Reservists are usually not allowed to attend AD training unless they are otherwise actively participating.

e. The applicant was promoted twice during the time period in question. These **promotions** would indicate **was** a participating member in good standing. See Promotion Orders 

f. For Retirement Year Ending (RYE) 21 August 1950, the applicant's record shows 15 AD points, and 15 membership points, resulting in 30 total and retirement points and an unsatisfactory year **of** Federal service.

4. Recommend this application be approved. The documentation in the applicant's record indicates **participated** in good faith and was promoted twice. If **this** application is approved, the following corrective action would be necessary:

a. For RYE 21 August 1950, award 20 non-paid **IDT** points. The applicant's record would then **show** 15 AD points, 20 **IDT** points, 0 Extension Course Institute points, and 15 membership points, resulting in 50 total and retirement points and a year of satisfactory Federal service.

b. The applicant's satisfactory Federal service will then total 20 years, 4 months and **20** days. This is enough satisfactory Federal service to make **eligible** for retired pay under Title 10, Section 12731 (age 60 retirement).

5. If this application is disapproved, no further action is necessary.
