Under the authority of Section 1552, Title 10, United States Code, Air Force Instruction 36-2603, and having assured compliance with the provisions of the above regulation, the decision of the Air Force Board for Correction of Military Records is announced, and it is directed that:

The pertinent military records of the Department of the Air Force relating to [REDACTED] be corrected to show that he was credited with an additional five (5) non-paid Inactive Duty Training (IDT) points during the retirement/retention year 27 September 1992 through 26 September 1993, resulting in 50 total points; and, that the period 27 September 1992 through 26 September 1993 is a year of satisfactory Federal service for retirement.

1. The requested correction cannot be accomplished administratively at this headquarters.
2. The applicant requests the period 27 September 1992 to 26 September 1993 reflect a good year. He claims he was told by his unit recruiter he would not be able to attend any training until he finished his technical training school
3. The following is an analysis of the circumstances surrounding this case:
 - a. The applicant transferred from the United States Army Reserve (USAR) into the United States Air Force Reserve (USAFR) on 25 June 1993. Therefore, from 27 September 1992 to 24 June 1993 of the period in question, the applicant served in the USAR. According to the USAR the applicant earned 14 Active Duty (AD) points, 16 Inactive Duty Training (IDT) points and 0 Extension Course Institute (ECI) points.
 - b. The applicant did not participate for points while a member of the USAFR from 25 June 1993 to 26 September 1993. A memorandum from the applicant's Military Personnel Flight acknowledges the applicant was not allowed to participate until returning from technical training school
4. We recommend this application be approved. Had the applicant been allowed to participate from 25 June 1993 to 26 September 1993 enough points could have been earned for a satisfactory year of service. In order to correct the applicant's record the board would have to award five non-paid IDT points for retention/retirement year 27 September 1992 to 26 September 1993. The applicant's record would then show 14 AD points, 21 IDT points, 0 ECI points, 15 membership points and a year of satisfactory Federal service.
